Conditions of use

- Any plumbing must be carried out by a registered plumber.
 - It is not suitable for accessibility facilities.
 - The bath should be mounted on a level floor in a waterproof room which has been finished in a material which is suitable for wet areas
 - For safety reasons, the hot water temperature must be limited to 50° C

Maintenance Requirements

To avoid soap build-up or water lines in your bath, rinse it with warm water right after each use. Once the bath dries, soap scum and dirty rings become harder to clean. Never use scourers on acrylic surfaces, as they can scratch and dull the finish. To prevent mold, install a fan to remove moisture from the room.
